6. PRESIDENT'S REPORT

First and foremost I would like to extend my congratulations to Carlingford and Rydalmere Bowling Clubs for the hosting of the Grade 4 State Pennant finals. Both clubs did a superb job, and to their Management, Staff and Volunteers my sincere thanks for the tremendous effort and for all the work put in to ensure the success, it undoubtedly was.

A very busy time on the zone bowls front, with State events, pennant playoffs, rookies and champion of champions competitions completed, underway or scheduled in the next week or two. Congratulations to the winners decided thus far and good luck to those still to compete.

The side to compete in the Inter Zone Championships at Nelsons Bay B/C on the 9th 10th and 11th of September has been chosen and can be viewed on the Zone website. I would like to wish the side good luck and hope they can go one better than the one shot loss in last year's final.

There have been a number of disappointing comments and ill informed rumours circulating in regard to the proposed Mixed Pennants. I believe a number of clubs have not tried too hard to generate interest among their lady bowlers. I was recently in Dubbo for the ladies Pennant playoffs, and was surprised in the amount of interest, positive comment and feedback I received. There are a number of Districts watching our efforts to get the concept up and running, with great interest. I do not believe that men's and ladies bowls will survive in some clubs whilst there is a continuance of the attitude "lets do our own thing" in isolation. Clubs need a healthy relationship and co-operation between the men and the ladies, more particularly in the current economic climate in clubs generally.

The club at which I am a member is not a particularly large club, probably small by comparison to others within the zone, managed to get 42 teams to enter the club's Mixed Pairs championship, by far and away the biggest amount of entries ever for this event. To me this is a clear indication when the relationship between the men and women you will get some positive results. Further evidence to support this view is that our club has generated sufficient interest from both our male and female bowlers to enter two (2) A grade and two (2) B grade sides for the mixed pennants, that is 16 men and 16 ladies participating, who would otherwise probably not be bowling, and to me the name of the game is to generate participation and club activity.

Apathy is extremely difficult to defeat but the Zone is determined to give it an almighty effort to generate some different ideas, because at the end of the day doing the" same old same old "is not the answer.
