10. STATE COUNCILLOR'S REPORT

The new constitution will be voted on 15th December. In the light of no communications received from the clubs in Zone 10 the executive have decided to vote in the affirmative.

I would like to thank Toongabbie for helping the RNSWBA, at late notice taking on the Hosting of the AER Mixed tournament.

The Chairman of the SMC John Smith advised that he has been asked about players changing grading during the current season.

- The simple answer is that players establish a current season grading by playing either 4 matches or 50% of matches (whichever is lower) in a grade.
- If a player, in the current season, has established a grading by playing (say) 4 matches in a grade and then plays 4 matches in a higher grade, his current season grading then becomes the higher grade (and he is ineligible to play in the lower grade from that point onwards).

Treasurer Ron King reported that the Association appears to have a year to date loss of \$58,300. Overall the figures do not appear to be 'too bad' considering that in total membership the loss is 4.87%. The full membership loss is 4.66%. The loss in Junior Membership is 15.26%. The first two percentages are better than the previous year but the junior figure is worse. Total membership is 54302 at October

Lyle Keats (Vice President) attended the Northmead Bowling Club for the presentation of awards resulting from the Annual NSW Teachers v their Queensland Counterparts. Bowls Australia has advised that all Coach Reaccreditations must be completed within a time frame which is no earlier than six (6) months prior and no later than thirty (30) days after the expiry date of a Coach's current accreditation.

For example, if your current Coach Reaccreditation expires on the 30th June 2012, you are able to Re accredit between the 30th December 2012 and the 30th July 2012. Should reaccreditation not be attained within this time frame, it will be necessary for the candidate to attend a full Club Coach Course in order to regain accreditation as a Club Coach.
